Although I have known Frank for 20 years, I did really not get to know him until the last few years. He is difficult to really know, but once you do you discover his kindness, thoughtfulness and overall sense of decency.

This is why his crime is so devastating to him and all of us. We expect more from Frank. We are disappointed and sad for him.

This is what this letter is about. Frank is feeling this sense of betrayal and shame.

I strongly believe this is the most devastating aspect of Frank's plea; the sense he lost a

little of himself and what was good about him when he involved himself with this money. Frank knows he will never recapture that part of his worth, nor will we – but we still love him.

This disgrace on himself, the loss of his law license, and restitution of the amount at issue is enough. No goal of society or the system is met imprisoning this man.

Judge, thanks for listening.

Dear Judge Stiehl:

I am writing on behalf or Frank Fabbri whom I have known both as a close friend and a respected attorney colleague for over 20 years. Frank is charged with Failure to File IRS Form 8300 after receiving in excess of \$10,000.00 in cash on November 10, 2004. His sentencing hearing is scheduled for August 27, 2007 at 1:30 p.m.

It is my hope that the sentence you impose will reflect leniency for this decent individual whose career has otherwise been marked by diligence, honesty and exemplary service to his clients.

Although I live and practice in Kansas City, I am well acquainted with the hard work and personal sacrifices Frank has made as an attorney. Frank has an outstanding work ethic. On many occasions I have telephoned Frank during the evening well after 5:00 p.m. and discovered that he was still in the office. When I have inquired about the various matters that have kept him at the office, Frank has replied that he was preparing a brief, or motion or getting ready for trial. I do not know of any attorneys who are more dedicated to their work and their clients than Frank.

I am also acquainted with Frank's considerable skill in the courtroom as a criminal attorney. I once attended a motion hearing with Frank in which he argued a complicated motion before (Federal) Judge Elmo Hunter, a legendary jurist and legal scholar here in Kansas City, whose distinguished record was marked by the lowest reversal rate in the 8<sup>th</sup> Circuit. Although the hearing before Judge Hunter occurred over 10 years ago, I can vividly recall my admiration for the way in which Frank's persuasive advocacy completely dominated the proceeding. Frank's advocacy epitomized thorough preparation and zealous advocacy. In fact, Frank's presentation at the hearing was so powerful and compelling that he managed to overshadow Judge Hunter – at least in my eyes. In the more than 20 years that I have practiced law, I have never witnessed more effective advocacy.

The Frank Fabbri that I know is also humorous, thoughtful, generous and humble. This single episode that brings Frank before you is atypical and totally unrepresentative of the character of this honorable man.

My father, Robert D. Kingsland Sr. (now deceased) was a federal magistrate in St. Louis, Missouri was proud to call Frank Fabbri his friend – and so am I.

I know that it is not fashionable for judges to show lenience. Harsh and stern punishment seem to be the order of the day. Nevertheless, I appeal to you on the basis of fairness and equity to weigh Frank's good character and his exemplary service to our profession and mitigate the sentence you impose on him.

Dear Judge Stiehl:

I am writing you concerning Mr. Frank Fabbri, who will be sentenced by your court in the near future. Mr. Fabbri is a neighbor and member of the community in which I live in St. Louis. I have known Mr. Fabbri for almost 16 years, not only as a part of my neighborhood, but also through the many individuals I know in the legal profession. My wife is Judge Joan Burger of the St. Louis Circuit Court and my son Gary Burger Jr. is a licensed attorney in both Missouri and Illinois, so I have many friends and contacts in the legal community who, like myself, know Frank quite well. I would ask you to consider my comments below when you decide on Mr. Fabbri's sentence. Obviously, I cannot comment on the charges against Mr. Fabbri or the degree of his culpability for them. I can comment upon his character, his community involvement, and how he is perceived among my friends and acquaintances in St. Louis. Personally, I have always been impressed by Frank's commitment to his community and his profession. In many discussions with him over the years, I have been struck by his belief in the necessity of providing all individuals in our society the representation promised them by our legal system. It always seemed to me that he put his clients first and tried to represent them as well as he possibly could (based on our conversations), and that opinion seems to be shared by most of my "legal type" friends.

Frank has also been an upstanding and responsible member of our local community, He is liked and respected by my neighbors, and he has participated actively in many neighborhood events (e.g., block parties and the like), and has been concerned with us all about various local problems. In speaking with my neighbors and attorney friends about Frank, I have heard a strong consensus that the man we know does not seem to be one who has been convicted of a crime. The behavior we have witnessed from Frank over the years argues that he is a man of principle and commitment to his community and profession.

In summary, I have a very positive assessment of the character and behavior of Frank Fabbri, as do most of his neighbors and friends that I know and talk to. I hope you will consider these comments when you make your decision.

I believe these two classifications have very little in common and each case is unique, as is the case with Frank.


Frank is what I would characterize as an "old school" attorney. He would put up a serious fight in favor of his client's rights, reason for leniency on his client's behalf, and advise you he would work to uncover the truth if it was hidden from him. 

Since its inception in 1982 Black Alcohol/Drug Service Information Center [BASIC] is a multifaceted program imparting a continuum of services being provided in the field of chemical abuse. Our specific goals and objectives are: To have more people, Black in particular, receive services from the present chemical dependency recovery system; To implement community intervention methods; To cooperate with other community agencies in problem identification; To establish community support systems; and to provide a link between the Black community and chemical dependency service providers. Frank Fabbri has enthusiastically helped us pursue our goals and objectives for well over thirteen (13) years and has been on our Board of Directors since May 12, 1997.

Initially Frank came to visit us because he had heard about our program from one of our caseworkers and wanted to know more about it on a personal basis. (No other attorney, before or since, has expressed such a high level of curiosity and concern.) We readily accepted him because we had already heard of his unique ability as a White man to "connect" with minority youth and young adults and redirect them toward sobriety. We found, and still find, Frank's desire and abilities unique.

When Frank came to us, he had already developed a "kit" for presentation. Along with the help of a federal narcotics officer, Frank made two (2) sets of "dummy dope" samples: one set of 500 grams powder cocaine – 5 grams crack cocaine and the other set of 250 grams powder cocaine- 2 grams crack cocaine i.e. the mandatory minimum amounts in federal and Missouri courts. Frank had used his "kit" in compelling presentation before the Missouri Black Caucus and various minority churches and organizations to educate both minority youth and their parents. (Incidentally, his "kit" presentation now also includes an original (and very heavy) African slave leg cuff.)

We found Frank's sincerity compelling and he became a board member at our earliest opportunity. Some time after his acceptance, we found ourselves in need of a transport car for our clients. Frank, on his own, found a "one owner" 1972 Cadillac

limousine and, working on it at night in his garage, totally rehabbed it. He surprised us with the gift of a virtually "new" and clever transport car to alleviate our need of the time.

Frank has continued to provide us advice and has been our "spokesperson" within the courts system and the legal community. He has also, through his own experiences, helped us become more aware of our common goals within the entire St. Louis community and has helped our program reach out to all similarly situated dependants within our community irrespective of color. We feel that we have impacted upon Frank the way he has impacted on us.

We know that Frank is in trouble and that he will be punished both as a federal defendant and as an attorney. We ask that you not incarcerate him but direct that he perform community service at our facility here at the old historical Jefferson Bank in St. Louis. Incarceration now would provide nothing to help our community when, with Frank's unique talent and abilities, he can help us try to achieve our common goals in a daily and intense basis. We, quite "frankly", are a non-profit agency and not highly endowed and need special people like Frank to continue to help us in our quest. In exchange, we will provide any monitoring or other confirmatory information you might desire to satisfy any ordered commitment to us. We also guarantee that you would be performing a great and gracious public service to us and the whole St. Louis community by giving us the service of such a skilled and experienced man pro bono.
