vehicle approached the intersection, it appeared that it may not stop for the electric signal. While nearing the intersection, the vehicle decelerated quickly and stopped. I noticed that Freese's eyes were bloodshot and glassy. As I talked with Freese, I detected a strong odor of an intoxicating beverage on his breath as he spoke. I also noticed that Freese's speech was slurred. I returned to my patrol vehicle and conducted a computer check.

I recontacted Freese and and asked him to exit his vehicle. Freese exited and walked to the front of his vehicle. He appeared to be very unsteady as he walked. I asked Freese if he had consumed any alcohol. Freese stated that he had drank seven beers. I conducted a Horizontal Gaze Nystagmus test, a One Leg Stand Test and a Walk and Turn Test.
